For 2022, IDC TURKIYE will be open to submissions which align themselves to one of the categories listed.

*The categories here do **not** reflect the final number of awards that will be distributed.*

*Depending on the quality of submissions received, the judging committee may deem appropriate to present more than one accolade per category **or** withdraw an entire category altogether.*

Our judging criteria puts **heavy emphasis on the role of IT** in each submission, and the documentation you provide should detail this clearly.

Validation

IDC TURKIYE will consolidate and validate the information in the submission form. We will then contact the participating organization to ensure completeness of information before proceeding to the next step.

Submissions that do not qualify (such as being rolled out more than 18 months ago, being submitted by a party other than the 'owner' of the project, and so on) will be rejected without notice.

Assessment

Qualified submissions will be assessed and scored by the Cloud and Datacenter Advisory Board as well as IDC Turkiye analysts. Submissions should provide adequate details to address the following:

1. Angle of Innovation

- Does your project use a technology (or a group of technologies) in an unprecedented way in the industry?
- Does your project improve upon a common industry standard in IT?

2. Response to market need

- What existing gaps in consumer and/or regulatory requirements does the submission address?
- How does the solution help improve your organization's competitive positioning and overall business goals?

3. Effectiveness of implementation

- How was the business case for the submission justified and measured?
- Describe the partnership ecosystem of the project and the reasons behind its choice.
- How has the submission adhered-to/surpassed its budget and timeline expectations?

4. Market/end-user take-up

- Business benefits (projected or realized)
- Short, medium and long-term outlook

5. Business advantages

- Immediate impact on gross and/or net revenue
- Long-time impact on profitability
- How unique is the submission - is it well-differentiated from competing solutions, and can it be replicated?

6. Impact on customer/end-user

- Utilization rates and/or market adoption
- Perceived value by users
- Measurable value (key performance indicators)

PART 3: FAQ

Q: I would like to make a submission based on an ongoing project began more than 36 months ago. Will it be disqualified?

A: No, provided your initiative was still ongoing within the permitted period. The judges will only assess project phases that are delivered after October 2021, alongside relevant KPIs – anything beforehand would serve to provide context to the evaluation, but will not contribute directly to the final score.

Q: Can I make multiple submissions?

A: Yes, organizations can make multiple submissions up to 3 projects based on what they consider to be their most innovative projects in the last 18 months.

Q: Can a single submission be eligible for multiple award categories?

A: IDC Türkiye will allow submissions to be optionally entered into ONE primary category and ONE secondary category. The submission will then be judged according to different considerations/parameters relevant for each category.

Q: Will the information be shared with external parties?

A: No other end-user company or third-party vendors can access the submission forms without the prior approval from the participating organization.

Each submission will be treated with the highest confidentiality. Any information will only be limitedly disclosed to IDC Türkiye's senior domain experts and the independent panel of judges.
